SCI Double Impact becomes Mazars Thailand

SCI Double Impact Ltd. and SCI Audit Plus Ltd. have together become the first accounting firm in Thailand to fully integrate into an international partnership: Mazars.

On 19th February, His Excellency Dr. Friedrich Hamburger, European Ambassador and Head of the European Commission Delegation to Thailand, was invited to officiate the announcement of the merger between SCI Double Impact Group and Mazars at a function at the Dusit Thani Hotel in Bangkok.
